# Estimated expenses

## 2016–2017 Estimated Expenses for International Students

The following costs are estimated based on 12 semester hours for undergraduates and nine semester hours for graduate students during both the fall and spring semesters (one academic year). Actual expenses may vary. International students with F-1 or J-1 visa status must be enrolled full time, which is at least 12 semester hours per semester for undergraduates and nine semester hours for graduate students for both fall and spring semesters. Additional tuition and fees are charged if a student chooses to enroll in courses for the summer term.

\*If you choose to stay in the U.S. during the summer (May, June, July), you will want to have an additional \$3,129 for living expenses in the U.S. Summer tuition and fees are not included in the expenses and are additional.

Additionally, financial proof must be provided for any dependents accompanying you to the U.S.

You will receive a bill from the University for your tuition, fees, housing, and meals (if you live on campus). You may pay it all at once or a payment plan is available that allows you to pay your balance in four monthly installments. The first payment for the fall semester is due in August.
